



Terms and Conditions

The Terms and Conditions of use set out the terms on which you may make use of this website under the domain name www.medonehs.com as a guest or as a registered user. Please read these Terms and Conditions carefully before you start to use the website. By using the website, you indicate that you accept these Terms and Conditions and that you agree to abide by them. If you do not agree to these Terms and Conditions, please refrain from using the website.

1. **Information.** The website is operated by MedOne Healthcare Systems, a third-party administrator licensed by the State of Iowa whose principal place of business is at 1590 University Ave. Dubuque, IA 52001. MedOne Pharmacy Services, the primary mail order pharmacy for members served by MedOne Healthcare Systems, a mail-order & specialty pharmacy licensed by the State of Iowa Board of Pharmacy, is located at 1580 University Ave. Dubuque Iowa 52001.

MedOne Pharmacy Services is licensed as a non-resident pharmacy in the states of: Colorado; Illinois; Indiana; Kansas; Minnesota; Nebraska; North Dakota; South Dakota; Texas; Virginia; Wisconsin; and Wyoming. Only members served by MedOne Healthcare Systems may use services provided by MedOne Pharmacy Services. Members who live in states where MedOne Pharmacy Services is not currently licensed will be served by the MedOne Mail-Order Network of Partner Pharmacies.

Availability. We aim to update our site regularly and may change content over time. The website will normally be available 24 hours a day. MedOne will not be liable if for any reason this website is unavailable at any time or for any period. MedOne may suspend access temporarily and without notice in the case of system failure, maintenance or repair.

Certain sections of the website are restricted and require the user to first register and become a "Registered User" before accessing Registered User areas.
